

Particularly, due to the fact that as far back as matters pertaining to billions of Robert T. Stafford Disaster Act Funding that reveals federal court judges whose financial interests in the outcome of matters and cases pertaining to Hurricane-displaced and exiled survivors.

10. Numerous federal judges' and Catholic Dioceses' financial interests in matters being concealed would expose their roles in illegal organizations and scores of post-Katrina established businesses. In fact, the Lafayette Bar Association, the Shreveport Bar Association, and the several Federal Bar Associations are among those that have inappropriate and non-divulged dealings with an array of tax-exempt organizations, projects, and programs that operate out of the New Orleans Catholic Archdiocese and the Lafayette Catholic Diocese. Among such concealed

facts are reasons why scores of disaster survivors are impoverished, homeless, and impeded from fair chances at economic opportunities. Meanwhile scores of judicial personnel and their families are enriched by ensuring that poverty becomes maintained since indigence guarantees Department of Housing and Urban Development as well as other government funding and programs.

### ARGUMENTS

11. Plaintiff [REDACTED] in proper person received on November 29, 2017 via United States mail, a postal service final agency decision. On February 21, 2018 Plaintiff filed her "mixed-motives" Title VII discrimination case in federal court wherein she named only the postal agency as defendant; and she amended her lawsuit allegations on May 18, 2018 **before** service of process on the postal agency Defendant. Both the initial and amended lawsuit filed by [REDACTED] were served together with a summons on the Postal Defendant. Moreover, [REDACTED] timely filed her EEO claims with the agency and timely filed her lawsuit for discrimination in federal court;
